ASX Market Announcements

COMPLETED AIRCORE DRILLING FOR RARE EARTH ELEMENTS ("REEs") IN SA




Figure 1 Ausmon South Australian Tenements - black

Ausmon Resources Limited ("Company") is pleased to advise that the small Aircore drilling program within the Parrakie EL 6795 tenement in Limestone Coast, South Australia (**Figure 1**) announced on 12 September 2025 for REEs has been completed as scheduled.

21 holes (**Figure 3 and Table 1**) each to depth of up to 20 metres for a total of 382 metres have been drilled. The 382 samples collected will be scanned with pXRF equipment to identify presence of REEs. Samples indicating high grade REEs, if any, will be sent to ALS Laboratory in Adelaide for assay of Total Rare Earth Oxide ("TREO").

The results from this drilling program will enhance understanding of the REEs development within area LC003 (Jabuk) (**Figure 3**) and also identify the relevant freehold land to be accessed for a grid based drill testing later in the year.

Following the 2024 and 2025 road verge drilling programs (see AOA ASX Announcement of 30 July 2025 and 21 March 2024) the Company has identified a trend of mineralisation which covers significant acreage of approximately 122 km² delineated within 3 shaded areas LC001, LC002 and LC003(Jabuk) (Figure 2) with elevated REEs. The road verge drilling programs were very broadly spaced (0.5 km to 1 km) to maximise coverage across the tenements at minimum costs and to identify areas with higher TREO grade. Follow-up drill will be more tightly spaced of the order of 200 m to 400 m to focus more closely on the areas with higher ppm TREO under grid based drilling programs. Future drilling within the identified areas will extend from road verges to freehold land that will require access agreements and community consultations.

Next Exploration Phase in Limestone Coast:

- Delineate proposed drill collars in all 3 areas LC001 to LC003 rank based on drill hole assays. Drilling will be subject to land access.
- Assemble cadastral information in the areas of interest including landholder details.
- Seek support of relevant landholders for land access agreements and local community for shallow grid based aircore drilling.
- Confirm drill hole locations and plan financing of the program budget.
- Commence planning and conduct of drilling programs.

Australian Rare Earths (ASX:AR3), exploring to the south of these tenements has reported significant exploration success with estimated JORC 2012 resource of 236 Mt @ 748 ppm Total Rare Earth Oxides (TREO) (AR3 ASX Release on 30 September 2024).
