Permitting Milestone Advances Ravensthorpe Gold Project

Key Points:

- Ravensthorpe Gold Project (RGP): Public comment period under the EPBC Act Assessment process has concluded with no submissions received
- Represents an important step forward for the Company's sulphide development strategy, which involves mining at Ravensthorpe and processing at Forrestania
- Final documents to be submitted in October 2025, with an assessment decision expected before year end

Medallion Metals Ltd (ASX: MM8, Medallion or the Company) is pleased to provide the following update on permitting activities for the proposed development of the Ravensthorpe Gold Project (RGP and the Project).

The Company has now progressed to the next key stage under the **Environment Protection and Biodiversity Conservation Act 1999 (EPBC Act)**, administered by the Department of Climate Change, Energy, the Environment and Water (**DCCEEW**).

RGP (project 2024/10045) is being assessed on Preliminary Documentation, including a 20-business day public comment period. That process has now concluded with **no comments received**, marking a positive milestone in the Company's progression of approvals to enable implementation of the sulphide production strategy.

Medallion will collate and lodge finalised documents with DCCEEW during **October 2025**. Under the EPBC assessment framework, a decision is required within 40 business days of final documentation being accepted. Medallion anticipates an assessment decision in the **latter part of calendar 2025**.

Approval under the EPBC Act is the key **primary approval** outstanding for the proposed development of RGP. With permitting under Western Australian legislation already well advanced for both Ravensthorpe and Forrestania, this approval will be critical in determining the development timeline, subject to completion of the proposed Forrestania acquisition¹. Further secondary approvals will also be required under State (WA) legislation.
