archTIS Secures Additional U.S. DoD Contract to Provide Customised Development Services

Contract further validates and expands archTIS' NC Protect in the U.S. DoD for Microsoft DoD365

HIGHLIGHTS:

- archTIS has secured a second contract valued at A\$250,000 to provide services to Copper River Technologies on behalf of the U.S. Department of Defense ("U.S. DoD").
- Services include new development work for the NC Protect product to build new features requested by the U.S. DOD specifically for the U.S. Microsoft DoD365 environment.
- The contract is complementary to the ongoing progression with U.S. DoD for a large licensing deal as outlined in the ASX Announcement dated 16 June 2025.¹

archTIS Limited (ASX:AR9, OTCQB:ARHLF) ("archTIS" or the "Company"), is pleased to announce that it has secured a contract to provide services to Copper River Technologies ("Copper River") on behalf of the U.S. DoD. archTIS will provide services for its NC Protect product, specifically to develop new features requested by the U.S. DOD for additional functionality and deeper integration with existing Defense classification and Microsoft tools in a highly classified security environment. On completion of this contract work, the Company will be looking to enter into a large licensing deal for its NC Protect product and continued support for the expected additional licensing sales. The engagement is being procured and managed through Copper River Technologies, a U.S.-based federal contract holder and reseller of archTIS' products.

The new features address mission-specific requirements essential for enterprise rollout. While modest in immediate financial value, this contract represents a critical operational bridge between the initial license issuance and a broader enterprise award. It enables continuous collaboration, accelerates product enhancements demanded by the DoD, and positions archTIS for the broader multi-phase adoption expected to scale from thousands to potentially hundreds of thousands of users over the coming period.

The value of the contract is A\$250,000 to provide services which must be completed by 16 January 2026. Either party may terminate the contract for cause or convenience with written notice.

Commenting on the contract, archTIS Managing Director & CEO, Mr Daniel Lai, stated:

"Securing this contract to support new features and deployment services into the U.S. Department of Defense demonstrates clear customer validation and investment into NC Protect and its readiness in mission-critical environments. This added milestone provides confidence as we accelerate our U.S. expansion off the back of the Spirion acquisition and reinforces archTIS' ability to scale and deliver differentiated high-value data-centric security
