# Liontown partners with Metalshub to launch its first spodumene concentrate auction

Liontown Resources Limited (ASX : LTR) (the Company or Liontown) is pleased to announce it has joined Metalshub to streamline and digitalise spot sales of Kathleen Valley spodumene concentrate to its global customers.

The partnership marks a major milestone in the commercialisation of Liontown's world-class Kathleen Valley Lithium Operation, enabling transparent pricing, efficient processes and competitive access to global buyers.

Liontown is committed to leveraging innovation and technology to deliver long-term value for customers, shareholders, and partners in the global clean energy supply chain. Through Metalshub, Liontown will host a series of bidding events for Kathleen Valley spodumene concentrate into calendar year 2026 and beyond, allowing buyers to submit bids and purchase product directly via the platform.
