Mr Geoff Jamieson has decided it was time to step down from the role of Managing Director after 13 years full time in Managing Director/CFO roles at Orcoda and Resource Connect. He will remain with the Company as CFO and Executive Director in a part time capacity to support Mr Bodegraven through his transition period and beyond as required.

Orcoda Chairman Brendan Mason said: "Geoff has played a key role in several successful mergers and acquisitions for Orcoda and guided Orcoda through a number of challenging periods including COVID with his calm steady leadership. The Board acknowledges his enormous contribution to the Company.
