UPDATE ON 3D GEOPHYSICAL CAMPAIGN AND MANAGEMENT APPOINTMENT

Po Valley Energy Limited (ASX: PVE) (“Po Valley” or “the Company”) is pleased to provide an update on activities in Italy.

3D Geophysical Campaign

Po Valley Energy announces the successful completion of its 3D geophysical acquisition campaign over the Selva Malvezzi licence area in Italy. This ambitious program, covering approximately 140 km², represents a major operational milestone for a company of our size. The data acquired will be instrumental in fine tuning the Company's 4 well development program in this license.

After laying out 8380 wireless geophones, data acquisition commenced on 13 November 2025 using single sweeps from four vibroseis trucks operating simultaneously in separate quadrants. In just 13 days, the team safely recorded 5,052 vibration points, with only three hours of standby due to severe weather conditions – an exceptional operational performance. The campaign benefitted from an unusually dry November period, but its success was primarily driven by extensive planning and the outstanding execution of our contractors and technical team.

The acquired data is now being collated and after the selection of a skilled contractor, will undergo time-domain volume processing over the coming months. This work will deliver a high-resolution three-dimensional subsurface model to support future field development planning and potential resource upgrades at Selva Malvezzi. Subsequent interpretation of the data will be done in-house. The Company is targeting communication of these results with the market in Q2/2026.

Kevin Bailey AM, Chairman and CEO, said: *“This was an ambitious work program for a small-cap company, and our team has delivered it extraordinarily well. The combination of careful planning, excellent field execution and favourable weather has allowed us to complete the survey safely, on Budget, ahead of schedule and with minimal downtime.*
