### SKYFII ENTERS THE UK & IRELAND MARKETS VIA NEW DISTRIBUTION AGREEMENT WITH DATA SOLUTIONS

#### Highlights

- Wholesale distribution agreement signed with a leading IT sales and marketing distributor in UK & Ireland, Data Solutions.
- SkyFii will provide data analytics services via Data Solutions to an established channel of resellers based in the UK and Ireland. Initially this will be within the channel Data Solutions has established with industry leading WiFi hardware provider Aruba Networks, now an HP company.
- Data Solutions currently reaches over 200 customers in the region through its distribution of Aruba Networks products.
- First pilot contract through Data Solutions has been signed with Eyre Square Shopping Centre in Galway, Ireland.
- Agreement aligns with SkyFii's growth strategy and builds further momentum in its international expansion strategy through partnerships with key distributors with excellent regional penetration.
- Further international opportunities in the pipeline across the UK.

Data services company SkyFii Limited (ASX: SKF) (**SkyFii, the Company**) is pleased to announce it has signed a wholesale distribution agreement with Data Solutions, a leading IT sales and marketing distributor in Ireland and the UK. Under the agreement, SkyFii will supply data analytics services to Data Solutions' reseller customers.

Data Solutions has a strong reputation for enabling high growth businesses to achieve high market penetration through its trusted relationships and strong existing market credibility. It is an established regional distributor of many leading brands including Citrix, Symantec, Arista and Aruba Network products and services. Data Solutions currently reaches over 400 reseller partners and thousands of end user customers in the region through its numerous distribution agreements.

Under the agreement, Data Solutions can sell SkyFii's services to existing Aruba resellers leveraging their exclusive distribution agreement with Aruba Networks. Data Solutions will be responsible for providing support to the end customers including account service and call centre enquiries. Alongside this, SkyFii will provide dedicated product support to all businesses that utilise SkyFii's services through Data Solutions.

The first pilot contract has also been signed and will be delivered through Data Solutions' reseller Electro Automation in the coming weeks. The trial services agreement has been signed with Eyre Square Shopping centre in the town of Galway, Ireland. This trial will commence within the coming weeks and will run for a 4 week period. It is anticipated that if successful, a full services contract will commence. SkyFii currently has a 90% conversion rate of pilots into full services contracts.

The distribution agreement is aligned with SkyFii's strategy to expand internationally through partnerships with distributors with excellent regional penetration.

*“The distribution agreement with Data Solution is an ideal partnership for SkyFii as we continue to expand internationally and begin to penetrate the UK and Ireland.
