### Skyfii Board Restructure

Skyfii Limited (ASX:SKF) (**Skyfii** or the **Company**) today announces a number of changes to its Board of Directors and management structure.

Non-Executive Chairman **Mr Gary Flowers** has resigned from the Board. Gary has chaired the company since its ASX-listing and has skilfully guided the company since, overseeing significant capital raisings, an evolution of the business model and significant customer wins. The Board extends its sincere thanks to Gary for his service and stewardship to the Company.

Replacing Gary as Non-Executive Chairman is previous Non-Executive Director, **Mr James Scott**. James is currently Chief Operating Officer, Seven Group Holdings. Skyfii is delighted to have someone with James' business acumen, experience and technology bent to oversee the company during its current transformation and accelerated expansion.

At the same, **Mr Chris Taylor** and **Mr Anthony Dunlop** have resigned from their non-executive director roles at Skyfii and the Board would like to thank Chris and Anthony for their significant contribution.

**Mr Andrew Johnson**, a senior Telco executive who joined the Skyfii Board at the time of its listing, will remain a Non-Executive Director of the Company.

In parallel with the Board changes set out above, Skyfii is pleased to advise that it is in the advanced stages of negotiating the appointment of a senior Australian property group executive to the position of Managing Director (Australia) and Chief Operating Officer. The new Managing Director (Australia) and Chief Operating Officer will lead an operating model and operations review across the business as well as driving sales and a sharp customer focus through the Australian business – where a strong pipeline of opportunities exists with a +90% conversion of trial to paying customers. Further details will be provided in due course.

**Mr Wayne Arthur** will remain as Chief Executive Officer of Skyfii and will lead the Company's push into the United States and United Kingdom, where interest and appetite for Skyfii's market-leading customer engagement and analytical tools are also very strong.

Skyfii looks forward to providing further updates on what is an exciting and new period of growth and realignment of its operating model in the coming weeks.
