### **Quarterly Activities Report – September 2018**

As commented upon in the Quarterly Activities Report for June 2018, the sustained high price of gold, and particularly in Australian dollars, continues to generate a high level of interest in gold opportunities. In this context, the Broula King site and facilities continues to attract interest.

The existing plant, and particularly the attached permits, provide an avenue for suitable ore sources to be treated in the short term. An increasing barrier to bringing new orebodies into production is the protracted, expensive and arduous permitting process. In addition, the general public attitude towards mining developments is becoming much more critical, so the time frame and complexity of permitting is a major factor in mine feasibility. In this context, the existing permits at Broula King, and the opportunity for rapid re-activation & production, are viewed as a major strategic asset.

A number of opportunities to utilise the existing plant and permitted status of the Broula King have been identified and assessed, and discussions are well advanced, with preliminary documentation exchanged. It is expected that one, or both, of these opportunities will proceed to signed agreements in the near term.

In addition, a geological review has been undertaken subsequent to the lodgement of the 2017/2018 Annual Exploration reports in respect of Mining Lease 1617 and Exploration Lease 8509 respectively.

M.L 1617 relates to the immediate environs of the Broula King mine & processing plant, and was the subject of an exploration drilling programme in March/April 2017 (previously reported in some detail in the Directors Report - Review of Operations in the Annual Report for the period ending 30 June 2017). Exploration Lease 8509 relates to approx 140 km2 of ground, surrounding M.L 1617.

It is considered that the 2017 drilling programme on M.L 1617, and an overview of regional prospects on E.L. 8509 (which in addition to M.L 1617, also includes 2 other granted Mining Leases encompassed within the E.L) provide a strong basis for further geological investigation, including a targeted programme of additional drilling. This exploration potential as outlined in the Exploration Reports has drawn favourable comment from a major shareholder, and an indication that they would consider support of any necessary funding, whether by way of equity and/or loan funds.

This potential for further exploration work has been held in abeyance pending resolution of the near term utilisation of the Broula King site and processing plant. However, the various activities being pursued are not exclusionary, and the recommended exploration work will be further pursued.

In respect of the company addressing the ASX determination that the Company may not comply with Listing Rule 12.1, and the necessity to demonstrate that it is compliant on or before 19 November 2018, the Company believes that it will be able to demonstrate that it is compliant. In particular, the initiatives to utilise the Broula King site to process off-site materials alluded to above are well advanced. In addition, the exploration potential outlined in the 2017/2018 Exploration Reports, and the favourable comment drawn from a supportive major shareholder, should provide a further factor towards compliance.

The consolidated entity has entered into a debt facility agreement with Asipac Group Pty Ltd, a major shareholder. On 24 October 2018, this facility was extended until 24 October 2019 and a further \$100,000 was provided to support the consolidated entity's activities.

The Company will rely on its existing cash resources and future capital raising (either debt and/or equity), including its ability to place securities under LR7.1 and LR7.1A to funds its current activities. In addition, the company has received a letter of comfort from major shareholder Asipac Group Pty Ltd, whereby it has confirmed that it will continue supporting the consolidated entity in respect of the financial support that may be necessary in the interim to enable the consolidated entity to meet its financial commitments. Until such time that the consolidated entity is able to raise alternative funding from a capital raising or alternate loan facility from elsewhere, Asipac undertakes that in the event of the consolidated entity not being able to repay all amounts due under the current Loan Facility at maturity that it will negotiate to restructure the terms of the Loan to accommodate the consolidated entity's financial requirements.

In light of the above factors, the Company believes that it will have sufficient cash to fund its existing activities. The Company expects to have negative cashflows from operations of approximately \$150,000 for the forthcoming quarter. The Company's Board and Management is focused on meeting its current objectives and confirm that it is in compliance with ASX Listing Rules, in particular, Listing Rule 3.1.
